Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 03 (01 section each for Bal Vatika-1, 2 and 3 respectively). The total number of sections from classes I to X shall be restricted to 10. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq. ft. dimension. The number of students in each class shall be restricted to 40.
2	Ramp/lift to access upper floors is not available. As school vide letter dated 13.12.2023 uploaded on SARAS portal has informed that work of installation of lift to access upper floors is under progress, school is hereby, directed to ensure installation of lift as per the provision laid in RPWD Act and Board's guidelines (https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf) within 03 months and submit compliance.
3	The school does not seem to have referred to RPwD Act and guidelines of the Board for CwSN toilets. The building is G+2, but 1 CwSN toilet for boys and 2 for girls are seen. The School shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage, indicating the floor number and with all infrastructural facilities, as per norms of RPwD Act and guidelines of the Board within 03 months and submit the compliance with videography.
4	General toilets separately for boys and girls are not available on every floor. Girls toilets are seen on ground and first floor only, whereas, toilets for boys are available on second floor. School shall make provision of separate toilets for boys and girls on every floor, within 03 months and submit the compliance with videography.
5	The boundary wall adjacent to the basket ball and volley ball courts is less than 6 feet in height. The school is required to increase the height of the boundary wall upto minimum 6 feet and submit the compliance through videography within 3 months on the SARAS portal.
6	School has less number of computers as specified in SoP issued by the Board vide Circular No.11 dated 04.10.2022. School is directed to increase the number of computers to minimum 40, as per SoP and submit compliance within 03 months.

7	Composite science lab has inadequate seating arrangement for students and cannot accommodate 40 student at a time. No safety features like exhaust fans and fire extinguishers are seen in the lab. School shall upgrade the lab as per Board's SoPs within 03 months and submit compliance.
	The school shall ensure the training of its teachers with CoE Chennai within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

- 1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school is required to renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

"The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms".

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
